We are all part of the St Mary's Family. The PTA's main objective is to strengthen our family with events that bring everybody together.

We also do a lot of fundraising to help enhance our children's time at St Mary's. Due to school cuts, our school needs our financial help more than ever.



Whether it's building an outdoor classroom, buying shiny new books for our classrooms and library, funding science equipment or bringing a Space Dome into school; the funds raised from the PTA's activities impact massively on the opportunities and experiences of all the children at school.

Did you know that until the school became an academy, many St Mary's Families used to contribute **£10 a month by standing order** towards the upkeep of the school buildings? Would you consider making a similar monthly donation to the PTA to help our school?



As the PTA is a **registered charity**, we can reclaim from HMRC an extra **£2.50 gift aid** for every £10 you give (at no extra cost to you).

If you are a higher rate tax payer you can reclaim a further £2.50 (so that your monthly donation of £10 only costs you £7.50 and the PTA gets £12.50!)

We would be very grateful if you could complete the attached standing order mandate form with whatever amount you would like to donate on a monthly basis. You can set a standing order up electronically if you wish but we can't reclaim the gift aid without the completion of the gift aid declaration.
